Lending Funds

Stonecrest's Lending Funds are mortgage funds for accredited investors, secured primarily by California real estate. An investor purchases shares of the fund, which then lends the money to borrowers. Borrowers make monthly interest payments and the fund then pays out dividends to investors. The fund's large number of highly diverse trust deed loans act as security for the investment.

Acquisition Funds

Stonecrest's Acquisition Funds allow accredited investors to benefit from returns resulting from REO (real estate owned) and NPML (non performing mortgage loan) bulk acquisitions. Investors purchase preferred interests in the fund, and proceeds are then used to buy and sell properties. Our aim is to provide note modification or resell each property quickly for cash. Assets are liquidated at the end of the fund's term and distributed to investors.

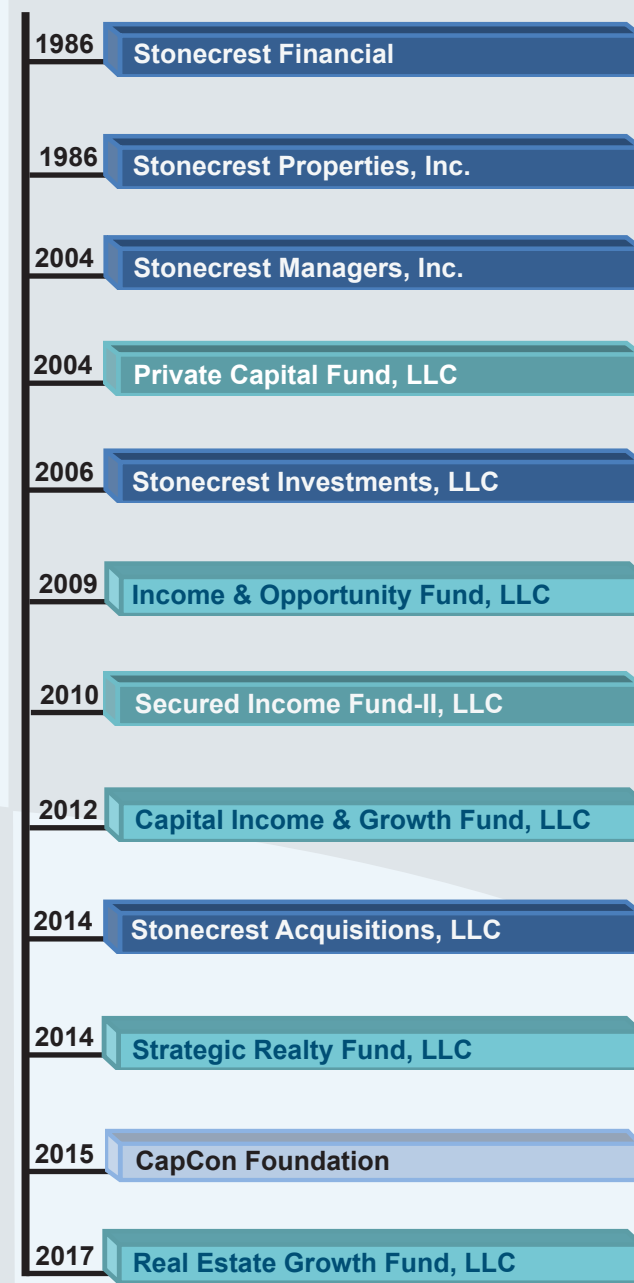
Stonecrest's CapCon Foundation
